From The Desk of the Head of State

14 NOVEMBER 2006

I, Fon Fongum Gorji-Dinka, Head of State of Ambazonia, in exercise of the powers vested in me by the Ambazonian Constitution do hereby make the following Ordinance:

CITATION:

This Ordinance shall be cited as Ambazonian Government and Parastatal Ordinance (AGPO).

ARTICLE I:

- 1. The Presidency
- 2. Prime Minister and Two Deputies.

ARTICLE II:

The Ambazonia Government shall for the immediate future be constituted with the following Ministries in alphabetical order:

- 1. Agriculture
- 2. Commerce and Industry
- 3. Communication and Transport
- 4. Culture and Heritage
- 5. Defense
- 6. Education and Scientific Research
- 7. Finance
- 8. Health and Welfare
- 9. Justice
- 10. Labor and Social Security
- 11. Lands and Environment
- 12. Mines and Power
- 13. Pan-African Affairs
- 14. Reconstruction
- 15. Youth and Sports.

ARTICLE III:

The following Parastatals are hereby created:

- 1. Ambazonia Development Corporation (ADC)
- 2. Ambazonia Energy Corporation (AMECO)
- 3. Ambazonia Hydro-Carbon Corporation (AHC)
- 4. Ambazonia Marketing Board (AMBO)
- 5. Ambazonia Mass-Transit Corporation (AMATCO)
- 6. Ambazonia Water Corporation (AWACO)
- 7. Central Bank of Ambazonia (CBA)

ARTICLE IV:

The Task Forces mentioned in 1993 Ordinance shall apply mutates mutandi.

ARTICLE V:

In the event of any conflict with an earlier Ordinance, this Ordinance shall prevail.
