ALIEN REPARTRIATION ORDINANCE

I, Fongum Gorji-Dinka, Head of State in exercise of the powers vested in me by the Ambazonian Constitution, do hereby, for the purpose of enforcing the Restoration law 84/01 and in execution of the Restoration Judgment HCB/28/92, each of which demands the total and unconditional withdrawal of Cameroon from Ambazonia; pursuant to the United Nations Committee on Civil and Political Rights decision of 17th March 2005, issue the following ordinance:

Citation: This ordinance may be cited as: *Alien Repatriation Ordinance (ARO)*

Article 1: All persons not being ethnic or adopted Ambazonians who are in Ambazonia for executing duties, functions or for exploiting a concession or license derived directly or indirectly from the Cameroon government are ordered with immediate effect to leave Ambazonia in compliance with expulsion order HCB/28/92 of the Cameroon High Court Bamenda;

Article 2: Such persons shall hand over all facilities and logistics within their control to the Ambazonian next in rank;

Article 3: This ordinance shall only apply to the Bakassi combat zone when and only when Nigeria proceeds to comply with the judgment of the International Court of Justice (ICJ) by handing Bakassi (which both Cameroon and Nigeria acknowledge to be part of Ambazonia) to Ambazonia;

Article 4: The Ambazonian people are directed to ensure that these Cameroon agents leave Ambazonia as soon as possible;

Article 5: Ambazonian Traditional Rulers, MPs and Municipal Councilors and Administrators, are hereby formally charged with the duty to lend moral and material assistance to their constituencies in executing this ordinance.

Article 6: This ordinance shall be posted on notice boards and public building; and may be served by hand or post on Francophone public servants presently in Ambazonia.
