**Bakassi: Jonathan to obey Court Orders or else !**

*President Jonathan*, risks a citation at the Code of Conduct Tribunal if he persists to ignore Federal High Court Orders even after prompting this public;

AN ORIGINATING SUMMONS by way of AN ORDER TO SHOW CAUSE why the following Orders, which became Orders Nisi, on being served on the defendants on the 6th October 2013, should not become Absolute; 30 days thereafter namely:-

1 A declaration that the Special Regime which illegally put the plaintiffs' Bakassi Peninsula under control of Cameroon, was null and void ab initio, on the grounds that it was created by the 12 June 2006 agreement concluded by signatories who lacked locus standi.

2 An order that the 1<sup>st</sup> defendant should cause all persons and logistics brought unto the Bakassi Peninsula under that Special Regime to be removed; and should deliver vacant possession of the said Peninsula to the plaintiffs.

2 An order that the 1<sup>st</sup> defendant should cause all persons and logistics brought unto the Bakassi Peninsula under that Special Regime to be removed; and should deliver vacant possession of the said Peninsula to the plaintiffs.

3 An order that the 1<sup>st</sup> defendant should ensure that Cameroon withdraws without condition, to its territorial boundaries at its independence on 1 January 1960, in compliance with the judgment of the International Court of Justice, in pursuance of which the United Nations obtained a commitment from the Cameroon President to comply saying "President Paul Biya of the Republic of Cameroon in a bid to provide lasting peace to the Bakassi conflict hereby commit myself and my government to respect the territorial boundaries of my country as obtained at its independence"

4 NOTE: Should the 1<sup>st</sup> Defendant ignore this NOTIFICATION, a citation would follow under the Nigerian Public Officers Code of Conduct section 9, punishable under section 18 (2) (a) by Code of Conduct Tribunal declaring his office vacant.
