## **RECONCILE WITH THE LORD GOD OR ELSE**

Our everlasting Father the Lord God is the cause and effect of all things seen and unseen,

He made Your Excellency President of Cameroun without elections. If Ahidjo had reconciled to the fact that Your becoming Cameroun President was the will of God he would have lived and died a great Cameroonian and his tomb would have been a monument for pilgrimage.

And then when it came to putting an end to the decades of the subjugation of God's children of Ambazonia by Franco-Cameroun armed forces, He the Lord God made Your Excellency enact **law 84/01 on 2 January 1984** which dissolved

the illegal union and thus restored the two countries back as mutually sovereign and independent of each other as they were before the ill-fated and much troubled merger of 1 October 1961.

Your Excellency only realized the importance of law 84/01 when I wrote in 1985 asking Your Excellency to comply with law 84/01 by withdrawing from Ambazonia to the territorial boundaries of Cameroun at its independence. Instead of implementing Your own law Your Excellency arrested and charged me before Cameroun Military Tribunal with high treason punishable with death by a firing squad, because I called on Your Excellency to implement Your own law.

But just as the lions which were to tear and eat up Prophet Daniel each crawled supinely licking Daniel's feet like poppies dogs, so did the Lord God turn Cameroun military tribunal into His agents to dismiss the case and release me.

Instead of reconciling with God's verdict Your Excellency rearrested me, and put me under indefinite house arrest from which the Lord God enabled me to make my escape into exile. So from 1985 to this day just for asking Your Excellency to implement Your own law 84/01 Your Excellency has made me a wanted criminal.

But then in 1992 the Lord gave us Cameroun High Court HCB/28/92 which:

- (a) declared Cameroun occupation of Ambazonia an act of aggression
- (b) ordered the withdrawal or expulsion of all elements of Cameroun rule from Ambazonia

But Your Excellency has ignore the Cameroun High Court judgment

Then in the *Cameroun-v-Nigeria* case the Lord got the International Court of Justice to order Cameroun and Nigeria to return to their territorial boundaries as obtained at independence. And in pursuance of the ICJ judgment He the Lord made Your Excellency sign the **United Nations Bakassi Accord** (UNBA) on 31 January 2005 saying "*I President Paul Biya of the Republic of Cameroon, in a bid to provide lasting peace to the Bakassi conflict, do hereby commit myself and my government to respect the territorial boundaries of my country as obtained at its independence*"

In 2009 the Lord God made the United Nations surveyors reconstruct huge pillars along the international boundary line separating Cameroun from Ambazonia; so as to confirm that Ambazonia is not part of Cameroun but is a sovereign nation

Come the 50<sup>th</sup> anniversary celebrations of Cameroun independence the Lord God sent the President of the United Nations General Assembly to dramatize the fact that in international law Ambazonia is a sovereign nation. He presented to Your

Excellency, in the plain view of the Heads of States and Heads of diplomatic missions in Yaounde, two framed maps; one for Cameroun and the other for Ambazonia. Thus showing that Cameroun, is occupying Ambazonia in violation of the United Nations Charter article 2 paragraph 4 and is guilty of an act of aggression.

Your Excellency under the UN Charter Article 51, Ambazonia whether alone or with the assistance of other nations or NGOs or Mercenaries is under an obligation to use force to flush Cameroun out of Ambazonia

The Lord made Abuja Federal High Court issue FHC/ABJ/CS/526/2013 which **(a)** declares the fraudulent *Special Transitional Regime* in Bakassi Peninsular null and void of legal effect, because it was created by the nebulous 12 June 2006 agreement concluded by signatories who lacked locus standi;

**(b)** order Nigeria's President Goodluck Jonathan **(i)** to send Cameroun out of Bakassi Peninsula and to deliver vacant possession of the Peninsula to Ambazonia **(ii)** to ensure that Cameroun implements the United Nations Bakassi Accord by withdrawing to the East of the Mongo River.

Your Excellency, enforcement of this judgment whether by Nigeria's forces or by Ambazonia using **Independent Bailiffs** NGOs or *Mercenaries* would surely plunge Cameroun into a war where Anglophone soldiers would prefer to shoot down their francophone colleagues instead of killing their Ambazonian compatriots. This is one reason why Francophone soldiers are opposed to any war against Ambazonia, they want a peacefully Cameroun withdrawal just as the merger was done peacefully in 1961

Which is why the three **MOST EMINENT CAMEROUN PERSONALITIES** next to Your Excellency namely, [Cameroun Senate President](#) and [the Cameroun National Assembly President](#) plus [the Cameroun Prime Minister](#), jointly presented a draft decree to Your Excellency to sign **(a)** withdrawing all elements of Cameroun rule from Ambazonia and **(b)** putting at the disposal of the Ambazonian Head of State 35% of Cameroun's current national budget, for the two countries to create the Confederacy of Ambazonia and Cameroun Independent Nations which I proposed in my open letter to Your Excellency published in the Cameroun News Paper *THE POST* of 24 October 2011 titled **WE MUST PREVENT A BLOOD BATH.**

Your Excellency, it is known that the draft decree was presented to You in June 2014 by the three **Most Eminent Cameroun Personalities**, but to this day Your Excellency is pressured by a Beti clique not to obey what is indeed God's will for a peaceful solution to this problem.

What is most worrying is the rumours that Your Excellency has accepted the plot of the Beti clique to trigger a war to kill all Anglophones in Cameroun uniform, so as to kill the dream of an independent Ambazonian nation; Just as the Betis organized the killing of thousands of innocent Northerners in Cameroun uniform so as to kill the dream of a northerner ever again becoming president of Cameroun after the April 1984 Sali Ibrahim's failed coup d'etat.

Your Excellency be reminded that if Ahidjo had reconciled with God that it is God who made You President of Cameroun he would have lived and died a great Cameroonian and his tomb would have been a monument for pilgrimage; but the Lord God pushed him to organize the Sali Ibrahim coup d'etat. And the Lord got the very military tribunal Ahidjo set up for eliminating his adversaries to convict him Ahidjo of high treason. Ahidjo lived the rest of his life in psychological torture as a fugitive convict. He died and was buried a convict felon in foreign lands un-mourned and unsung. What an end for he who was daily hailed in Cameroun radio as *le pere fondateur de la nation*

So my beloved brother, on my bended knees I urge Your Excellency please, please, please fear God and reconcile with His holy will by urgently signing the decree which the **three most eminent Cameroun personalities** presented to Your Excellency; and by so doing Your Excellency would attract the abundant spiritual and material blessings that come unto them that do the will of God.

This I pray in the name and through the blood of our Lord Jesus Christ, now and forever more. Amen
