DECAMEROONISATION ORDINANCE

I, Fongum Gorji-Dinka, Head of State, in exercise of the powers vested in me by the Ambazonian Constitution, do hereby, for the purpose of enforcing the Restoration law 84/01 and in execution of the judgment of the High Court HCB/28/92, expelling all elements of Cameroon authority from Ambazonia, which judgment is further amplified by the United Nations Committee on Civil and Political Rights decision CCPR/C/83/D/1134/2002 of 17th March 2005, issue the following ordinance:

Citation: This ordinance may be cited as **DECAMEROONISATION ORDINANCE**

Article 1 *Interpretation: In this context:*

Psychological warfare: includes any thing that is meant to and /or is likely to brainwash or influence the mind of a person so as to create a bias for / or against a situation or a person, or a thing.

Cameroonisation: means imposing of a Cameroonian mentality, nationality on a place, person or thing including the brainwashing, acculturating or otherwise inculcating of Cameroon mentality, culture, bias or values in Ambazonia,

De-cameroonisation: means the opposite of the above; and including action to eliminate from Ambazonia, or Ambazonians, any symbol, flag, emblem, logo, photo, or other symbolism which orchestrates the Cameroon occupation of Ambazonia.

Article 1 The flying of a Cameroonian flag, or the posting of any emblem, logo, and photo of the Cameroonian President any where in Ambazonia is a violation of the Restoration Law 84/01 and the legal texts enforcing same, and amounts to aiding, abetting the enemy's psychological warfare against the Ambazonian people.

Article 2 It is the duty of every Ambazonian to eliminate any such Cameroon symbolism from Ambazonia; provided that the persons working in a place or office where such a symbolism

exists, who persist in keeping it shall have identified themselves as enemy agents.

Article 3 The transformation of baptismal names from English to French e.g. *Peter to Pierre, John to Jean, Monica to Monique*, etc. identifies the person:

- (a) as an innocent victim, once the person proceeds to rectify the situation;
- (b) as an enemy agent of Cameroon psychological warfare against Ambazonia if the person persists in being so identified.
