## From The Desk of the Head of State

I, Fongum Gorji-Dinka, Head of State in exercise of the powers vested in me by the Ambazonian Constitution, do hereby, for the purpose of enforcing the Restoration law 84/01 and in execution of the judgment of the High Court HCB/28/92, expelling all elements of Cameroon authority from Ambazonia, which judgment is further amplified by the United Nations Committee on Civil and Political Rights decision CCPR/C/83/D/1134/2002 of 17th March 2005, issue the following ordinance:

**Citation:** This ordinance may be cited as:

**Ambazonian Symbolism & Decameroonization  
Ordinance (ASDO)**

### **Article 1 *In view of the fact:***

- (i) *That by an Order-in-Council in Britain, Ambazonia (then described as United Nations Trust Territory of the Southern Cameroons under the United Kingdom Administration) became a constitutional monarchy with the Queen of England as Ambazonia's Head of State with effect from 1st October 1960.*
- (ii) *That consistent with that constitution the Union Jack became Ambazonia's flag, the Lion and a Unicorn fighting for a crown became Ambazonia's national Emblem; and God Save the Queen became Ambazonia's national anthem*
- (iii) *That in compliance with the Restoration Law 84/01 a Proclamation was dated 10 October 1990 formalizing*

**the Restoration of the independence of our Ambazonia which proclamation was filed at the United Nations of 27 October 1990, filed as an exhibit and became incorporated in the judgment of the High Court of Cameroon case HCB/28/92 .**

- (iv) That the said proclamation did simply Ambazonised the constitutional text by replacing all mention of British Personalities with Ambazonian Head of State leaving the symbolisms for determination by a subsequent text.**
- (v) That the process of liberating the Ambazonians mentality and psyche from Cameroon indoctrination demands an end to Cameroon symbols of authority over Ambazonia.**

**NOW therefore this ordinance stipulates as follows:**

**Article 2 The Ambazonian Flag is called *THE NEW GLORY***

**Article 3 The Ambazonian Emblem: *The Pax Dei: The Reign of God the Omnipotent, Omnipresent, and Omniscient* on earth.**

**Article 5 The Ambazonian National Anthem: *Hail Ambazonia Land of God.***

**Article 6 Cameroon flag, emblem, posters or photos signifying the occupation and subjugation of Ambazonia by Cameroon are hereby proscribed and shall be replaced by the Ambazonian Flag *The New Glory.***

**Article 7 Ambazonia's psychological war effort demands that all companies including banks in Ambazonia, and/or exploiting be it petroleum, mineral, agricultural or other resources, located in Ambazonia, land, territorial waters shall fly the Ambazonian flag 24 hours every day.**

**Article 8** Who so ever fails, or refuses to, or hinders, or in any way obstructs the implementation of this ordinance has opted to identify himself or herself as an enemy agent; and attracts an appropriate response.

**Article 9** Ambazonians shall enforce this ordinance on every company operating in Ambazonia through picketing or the boycott of the company or the transfer of accounts from the Bank.

**Article 11** Ambazonians are to demonstrate their patriotism by displaying the *New Glory* on vehicles, offices, house tops, doors, hills, farms, and gardens thus giving thanks, honour and glorification to the Lord Jesus Christ who is setting Ambazonia free from the powers of darkness. And those who so do will testify of His blessing and miracles sooner or later.
